- Nominations and Sustaining payments must be postmarked by the date specified. If a nominating or sustaining payment date falls on a Saturday, Sunday or postal holiday, then payments must be postmarked on the next day that the Post Office is open. There is no “grace period”. If postal service in your town is such that mail is only processed occasionally, it is still your responsibility to see that your payment is postmarked by the due date. You may use an overnight service such as FedEx or UPS. If you do, the date marked on the waybill as “received” by the delivery service is the date payment was made. Failure to timely make a sustaining or delinquent option payment will result in cancellation of the nomination.
 - All checks returned by the bank will constitute nonpayment and result in the cancellation of the nomination.
 - There will be no refunds of fees.
 - An advertising/clerical fee of \$50.00 will be deducted from the original, supplemental and delinquent nominations.
 - * An additional fee of 3% will be added to all credit card payments. This includes original, sustaining, supplemental and entry fees.

- Late Nominations & Sustaining Payments
- FOR ALL NOMINATING AND SUSTAINING PAYMENTS, EXCEPT THE TRIAL ENTRY FEE, DURING A PERIOD INCLUDING THE THIRTIETH (30) DAY FOLLOWING EACH DEADLINE, ANY OWNER MAY ESTABLISH / RE-ESTABLISH HIS ENTRY’S ELIGIBILITY BY SUBMITTING A PAYMENT OF TWICE THE REGULAR FEE DUE ON THE PRESCRIBED DEADLINE. ***YOU MUST NOMINATE TO BE ELIGIBLE TO SUSTAIN***

RULES GOVERNING 2026 NEW MEXICO STATE FAIR THOROUGHBRED FUTURITY

PAYMENTS

Rules governing payments are detailed on the front side of this form.

TERMINATION OF FINALIST

- Participants in the finals will qualify from the Trial heats based on order of finish.
 - If a tie exists, the horses involved will draw lots.
 - If more than twelve Trials are necessary, the twelve winners posting the fastest times will qualify for the finals.
 - In the event of a dead heat, both horses will be equal for purposes of qualifying.
 - The number of horses in each Trial will be decided by the management, but not more than twelve (12) horses will run in any Trial heat, and not more than (12) horses will be permitted to run in the finals of this Stakes.
- If any part of any entry is disqualified, it may disqualify all of the entry.

There will be an Also Eligible list with the number of horses on the list to be determined by the number of trials run. Results of trial race drug tests must be received before entry to the finals. Should there be a positive drug test among the qualifiers, the New Mexico Racing Commission will notify the Downs at Albuquerque and the Downs will not accept entries from any horse with a positive test.

In addition to the above, the Downs at Albuquerque reserves the right to order additional drug testing above and beyond the drug testing of qualifying horses in trials; specifically, but not limited to: Qualifiers for all early closing stake races must have a negative Hair Test result prior to running in the finals. The test may be administered by the NMSRC or the Downs at Albuquerque, and the samples will be sent to a qualified testing lab for analysis.

All horses qualifying for the finals and also eligible horses will be hair tested and the cost of that hair test will be deducted from the owner’s Horsemen’s Bookkeeper account.

Entries from the Also Eligible list will be accepted to fill the vacated spots in the finals

All nominated horses are subject to a pre-race inspection.

CANCELLATIONS

Nominations or subscriptions to this Stake may be refused or canceled without liability, at any time prior to the actual running thereof, except for the return of any nominations and entry fees paid. The Downs at Albuquerque reserves the right to cancel or postpone this race and/ or Trials for this race for any reason which it deems good and sufficient, with the consent of the New Mexico Racing Commission.

NOMINATORS RESPONSIBILITY

It shall be the nominator’s responsibility to notify the association of ownership and address changes. It is the responsibility of the nominator to understand the rules and payments on this nomination blank.

The Downs at Albuquerque offers a cash reward up to \$5,000 for confidential information provided to the Downs’ racing management that leads to the discovery of illegal or illicit substances used on horses or present on its premises. Each reward will be paid to the first person providing the information and verified that the tip/information has led to the discovery of illegal substances or direct proof that an illegal substance(s) was used on a horse. Any payment hereunder will be confidential.

The Downs at Albuquerque reserves the right to conduct random blood and hair testing on any horse on its premises. The random testing will occur at any time and at any place. The horse will be tested for Class A and Class B substances by a special lab in New York.

The Downs reserves the right to search any person, vehicle, horse stall, trailer, and other personal property present on its premises. Refusing a test or a search will be considered a positive test/violation. Violators and all related horses and property will be subject to immediate removal from the premises.

The Downs reserves the right and will place security cameras throughout the premises, including but not limited to the barn area and individual horse stalls. The cameras may be placed in conspicuous locations or hidden. The primary purpose of the cameras is to ensure that no illicit or illegal activities are being conducted on the premises.

During a pre-race inspection by the Regulatory Veterinarian any horse scratched due to musculoskeletal issues may not enter a race at the Downs at Albuquerque until the Downs is presented with a clear ultrasound or x-ray of the area of concern and approved by the Regulatory Veterinarian.
